MINUTES OF THE BOARD OF TRUSTEES MEETING

April 10, 2006

<u>Present</u>: Karen Burkinshaw, Norman Muller, Dee Desroches, Janet Reopel, Dick LaCasse, Bill Brunelle and. Six unit owners were present.

The meeting was called to order at 6:30 p.m.

Ouestions/Comments from the floor:

- C: Our purchase of smoke detectors is temporarily on hold as we research the possibility of combination carbon monoxide with the smoke detectors.
- C: We want a rep from the Fire Dept. to come to a meeting and give us the correct information concerning the new carbon monoxide laws and what we'll need. We've received differing versions of this information so far.
- C: New owners in Unit 26 came to introduce themselves.
- Q: Did we spray for ants? One of the units has noticed that there are fewer ants now. A: Yes, the perimeters of several buildings have been sprayed for ants expect to finish all the buildings shortly.
- C: Unit owner wants "plantings" instead of a tree on the "island" in front of Building 6.
- C: Unit owner complained of a bare spot behind building 3. Grass seed seems to simply wash away, won't take hold. A: Matter has been brought to landscaper's attention.
- C: Still having gutter problem behind unit 23. A: Mr. Home will come and look at the problem.

Minutes:

A motion was made and seconded to accept the minutes of the March 28th meeting. VOTE PASSED

Grounds:

- Some discussion about re-doing the asphalt in front of and to the side of Building 11 and a new
 dumpster arrangement. We will ask Bill Shaheen to draw up a plan to move the sidewalk in front of
 the dumpster closer to Building 11 and give us thoughts about a dumpster enclosure. This project will
 also involve cement work. We want to keep the enclosure as far from Building 3 as possible and to
 keep it centered.
- We will ask Mr. Winn from Alton Gleason (paving company) will come and talk to the board at a closed meeting about the asphalt problems. We will also try to get a rep from Palmer Paving for the same night. Bill will also call Mohawk Paving.
- One of the 10-yard dumpsters is slated to be removed to see if we can get along with just one for non-recyclable items. We are assured that a complex our size, if recycling is done properly, that 1 10 yard dumpster is sufficient.

It now becomes imperative that all residents recycle to keep the dumpster from filling up too quickly. All large items <u>must</u> be taken to the dump.

- We are going to request 2 more recycle "toters", (for glass, cans and metal) or ask that the 8 we have now be emptied weekly instead of every other week.
- A motion was made and seconded to hire Mr. Home to fix 40 feet of gutters in the front of units 23 & 24 at a cost not to exceed \$220. <u>VOTE PASSED</u>
- A motion was made and seconded to "edge" and fill with rocks 10 more light posts and/or trees on the property at a cost of \$25 each, at a cost not to exceed \$250. <u>VOTE PASSED</u>
- We received 4 landscaping bids from: Pioneer, Bombard, Soncini and BMC. A motion was made and seconded to hire BMC to do our landscaping for this year. <u>VOTE PASSED</u>
- A motion was made and seconded to have one to two inches of mulch put down as soon as possible after the "spring clean up" at a cost not to exceed \$5,000. <u>VOTE PASSED</u>
- We will invite Tom Smith, the landscape architect, back to give us more design ideas for either one
 entire building or several trouble "spots".

Buildings:

- New shutters were installed on Unit 72.
- A motion was made and seconded to purchase a new set of shutters @ 26.50 for Building 9. <u>VOTE</u> PASSED
- A motion was made and seconded to keep the Meeting Room rental charge at \$25 with a \$100 refundable deposit. VOTE PASSED

The next regular business meeting will be held on Tuesday, May16th at 6:30 p.m. in the meeting room, and all are welcome to attend.

There being no further business, the meeting was adjourned at 9:15 p.m.
