Comments from the Floor:

• We received a complaint from a unit owner.

#### Meeting Minutes:

• A motion was made and seconded to accept the minutes of the November 9 meeting. Vote: Passed.

#### Finances:

- As of today, we have \$22,859.70 in checking and \$142,936.21 in reserves for a grand total of \$165,795.91.
- As of today, we have \$12,517.99 in arrearages. Four owners owe a total of \$426. The remainder is owed by the estate of a unit owner and will be settled when the unit is sold.
- A motion was made and seconded to adopt a 2022 budget that will raise \$264,960 and will set the monthly condo fees at \$260 for the two-bedroom units and \$204 for the one-bedroom units. Vote: Passed.

Legal:

• The Chicopee Conservation Commission signed a new Certificate of Compliance. We need to file it at the Hampden County Registry of Deeds.

Snow Removal:

• We are still negotiating our new 2021-2022 contract. In the event of snow before the contract is executed, our contractor will charge last year's rates.

Landscaping:

• Fall cleanup is scheduled to be completed this week.

Grounds/Property:

• Last week's heavy rain caused minor problems behind Building 2. Ed Severance reviewed the area today and will have the catch basin in that area cleaned out. Other corrections will be made in the spring.

## Buildings:

- Gutters are scheduled to be cleaned later this week.
- We are planning to have new rain handlers installed on Buildings 1 and 2 soon.
- We have hired Pro Tech to repair the Unit 3 cellar crack. They will notify us when the work is scheduled to be done.

Unit Issues:

- Trustees discussed unit issues.
- Last Friday's torrential rains caused a few water problems and these are being looked into.

New Business:

• Future meeting: Tuesday, November 30.

There being no further business, the meeting adjourned at 8:15 p.m. Our next meeting will be on Tuesday, November 30, at 6:30 p.m. in the Meeting Room. All owners are invited to attend.
