- A motion was made and seconded to purchase numbers to identify the cellars in Buildings 1, 4, and 11 at a cost of \$26.01. Vote: Passed.

## Landscaping:

- We will be meeting with a tree person from 16 Acres Garden Center to talk about what trees would be appropriate to plant at various spots on the property.
- We still need to look into upgrading our irrigation system.

# Grounds/Property:

- We are still looking to get quotes to redo the main dumpster pad.
- We would like to have all cellar window frames painted this summer.
- We have two quotes to reline and renumber our parking spots and we will get a third quote later this week.
- The Building 8, 9, and 10 waste pipes were cleaned yesterday and we were advised that residents should NOT flush baby wipes or wet wipes as these get hung up in the waste lines and could cause a blockage.

# Buildings:

- We are still working on moving the Building 1 doorbell/intercom system.
- We received a quote to replace the Building 4 front doors and we need to get clarification on a few issues. We also need to get other quotes.
- New back doors for Building 4 have been ordered and they should be in shortly.

### **New Business:**

- We plan to schedule a meeting for new owners in March.
- March meetings: March 10 and March 24.

## Unit Issues:

Trustees discussed several individual unit issues.
