- The Building 8, 9, and 10 deck footings were inspected and one footing on the Unit 67 deck needs to be replaced. An email motion was made and seconded to have this repair done as well as add joist hangers to the underside of the deck. Vote: Passed.
- We have an ongoing issue regarding feeding of birds and wildlife behind Building 7.

Buildings:

- The bee problem at the end of Building 3 has been resolved and the damage repaired.
- The Unit 45-46 railings have been reinstalled. We are waiting for a bill.
- Two people looked at the crack in the sidewalk in front of Unit 47 and both agreed there is nothing to worry about.
- We received a quote to replace the gutter on the back of Building 6 with a larger one. We will get other quotes before making a decision.
