- We are waiting for the steps and railings to be manufactured for units 15 & 16 and unit 41. Once materials are ready, we will coordinate installation and removal of existing materials between both contractors and the appropriate unit owners.

Landscaping:

Nothing new to report.

Grounds and Property:

- We are on the schedule for Crossroads installation. Timing is tentatively scheduled for the fall.
- Hastie Fence has been on the property to make needed repairs to the stockade fence surrounding the perimeter of the property.

Old Business:

• We had one interview for a handyman and will be scheduling another interview in the next week. Several calls to potential handymen were met with no response.

New Business:

• Potential projects for fall.

There being no further business, the meeting was adjourned at 7:29 pm. Our next meeting will be Tuesday August 26th at 6:30. All unit owners are encouraged to attend.
