#### Finances:

- ★ As of today, we have \$36,812.14 in checking and \$120,433.70 in reserves for a grand total of \$157,245.84
- ★ Arrearages of \$499.00
- ★ Audit still in process.

#### Landscaping:

- ★ Received a quote on 5 different types of trees. \$200 \$500 each depending on size.
  - o Flowering Plum Tree
  - Sargent Cherry
  - o Thundercloud Cherry/Plum
  - o Royal Pear
  - Brandywine Maple

#### Grounds/Property:

- ★ Buildings 8,9,10 waste pipes were cleaned. They did note that there are tree roots in the waste pipes of buildings 8 and 10. We should look into this issue again in the spring.
- ★ Fire hydrant issue we got quotes from E.J. Prescott, The cost being \$1285.00 with any needed repairs at an additional charge. The board decided to move ahead with this ASAP as it is a safety issue. They are coming on September 19th. Please do not use water while they are here and for a few hours after. You can flush toilets. During and for

a few hours after your water will be discolored, the main concern is to NOT run your hot water as you don't want to get the particulate in your water heaters.

#### Buildings:

- ★ We had people come in and quote for the common hallway cleanings. We are going to continue looking for quotes at this time.
- ★ We were able to have someone come in and quote for the painting of the front doors of Building 1. It was quoted at \$2200.
- ★ A quote was given for 20 cellar windows to be cleaned, caulked and painted. \$4600
- ★ Hallway painting in common hallways is going to have to wait until next fiscal year.

#### Old Business:

★ Search for a handy person in on going.

#### **New Business:**

- ★ Trustees need to schedule a welcome meeting for the new owners of units 3, 6, and 11.
- ★ Question: Anyone noticing pole lights staying on later than usual?
